World Wide Fund for Nature- India (WWF-India)



WWF-India is one of the largest conservation organisations engaged in wildlife and nature conservation in the country. Established as a Charitable Trust on November 27, 1969, it has an experience of over five decades now in the field. From a modest beginning, the organisation has been propelled forward by the efforts of its founders and associates who volunteered their time and energy to lend momentum to the conservation movement.

Today, it is recognised as a premier international conservation non-governmental organisation in the country dealing with nature conservation, environmental protection and development-related issues.

At a time when the Web of Life has come under increasing threats, WWF-India's attempts have been to find and implement solutions so that human beings can live in harmony with nature, and leave for future generations a world rich in natural resources and natural wonders.



To suit India's specific ecological and socio-cultural situation, WWF-India articulated its mission in 1987 as follows:

CENTRE FOR ENVIRONMENTAL LAW

The Centre for Environmental Law (CEL) was established in 1993 as an integral part of WWF-India. Apart from handling and furthering WWF-India's conservation work involving policy analysis, campaigning and legal interventions on environmental issues, CEL serves as a resource centre for teaching environmental law and research in national, regional and international contexts.

To implement its programmes, CEL is building functional and professional linkages with government agencies and non-governmental organisations at national and global levels.

One of the principal educational activities of CEL began in 1993 with its flagship Diploma Programme in Environmental Law, which was mainstreamed in 2003 to the Post Graduate Diploma in Environmental Law. More than fifteen hundred participants have benefited from the three-decade-long efforts of the CEL Team at WWF India.

NATIONAL LAW UNIVERSITY, DELHI (NLUD)

National Law University, Delhi is a premier Law University established in 2008 by the Delhi Government at the initiative of the Delhi High Court. It has state-of-the-art infrastructure and facilities for learning and research.

NLUD has been offering a five-year Integrated B.A. LL.B (Hon.) Programme since 2008 and LL.M. and Ph.D. programmes since 2011. This exclusive tailor-made programme provides opportunities for law graduates and professionals working in the field of environment to enrich their understanding of the issues, institutions and initiatives in the field of environmental law and policy.

PROGRAMME OBJECTIVES

The main objectives of the programme are:

- Provide comprehensive knowledge to participants on Environmental Law and policy aspects.
- Increase understanding of key issues related to National as well as International Environmental Law & Policy.
- Develop knowledge on the International Legal & Policy context on thematic issues related to the environment.
- Develop practical skills to facilitate effective engagement with Environmental Law.
- Prepare well-informed professionals on Environmental Law and upgrade their professional competencies by augmenting specific skills on environmental law and management aspects.
- Promote networking and sharing of experiences among participants to actively contribute towards conservation.

TARGET GROUP

The programme is useful to students and working professionals from various streams who seek to enhance their skills on legal interventions for environmental protection and also bridge the gap between theory and practice.

Law graduates, Legal practitioners, Environmental professionals, Corporate Executives, Government officials, Media and NGO personnel seeking to enrich their professional knowledge are encouraged to apply.

ELIGIBILITY

- Graduation in any stream.
- Work experience, although not necessary, but a minimum of two years in the relevant field is desirable.
- Admission will be granted strictly on merit and at the discretion of Admissions Committee.

In some cases, the Applicant may be required to appear for a telephonic interview.

DURATION AND PEDAGOGY

- Post Graduate Diploma in Environmental Law and Policy is a one-year programme.
- The diploma is offered in English and is the only medium of instruction.
- All aspects such as course content, timelines, course curriculum, examinations and discussion forums will be conducted in the online mode.
- There are no online or Physical classes conducted in the PGDELP Course.
- Webinars and online discussion will be organized during course duration.

MODE OF STUDY

- Mode of instruction will be **ONLINE** only.
- For undertaking online mode study, participants need internet access.
- All course requirements like discussion forums and exam papers will be posted online. Participants will be provided with soft copy study/reading material.

COURSE CURRICULUM

The PGDELP programme comprises 32 Credits or 500 Marks.

It shall consist of 5 courses, including four theory-based courses and one Practical Training course. Courses 1 and 4 will be of 6 credits each, while Courses 2 and 3 will be of 8 credits each. The Practical Training course shall carry 4 credits. All the courses are compulsory.

The Course Manual contains an introduction to each unit in the individual Courses of the Programme and has a comprehensive compilation of a list of books, journals, media articles and key judicial pronouncements which should be referred to by the participants. It is dynamic in nature as it is a compilation of suggested readings of the recent developments related to the course.

The Course Manual will be shared with the participants online.

COURSE 5 PRACTICAL TRAINING

Term End Paper

Submission of the Final Term-End Paper is compulsory for completion of the PG Diploma.

EVALUATION PROCESS

The PGD programme follows a two-semester format, comprising four theory courses and one practical course (Term–End Paper). Evaluation is continuous and multi-modal, intended to holistically assess both conceptual understanding and applied skills.

Discussion Forums

Discussion Forums are conducted online, over the span of certain days, where the participating cohort members exchange ideas over a given topic of contemporary relevance. These forums are designed to facilitate peer learning, encourage critical engagement with legal developments, and apply course content to contemporary issues. Active participation in moderated online discussion forums is mandatory. Evaluation is based on originality, clarity, and relevance of contributions.

Take- Home Examinationss

At the end of each theory course, an open-book, online examination must be submitted. Examinations may include both objective and subjective components, testing conceptual grasp, analytical thinking, and practical application. All exam guidelines will be issued two weeks in advance. Submission of each examination is a prerequisite for progressing to the next course.

No re-sit, extension, or alternative paper will be provided.

Practical Course V (Term-End Paper)

Apart from the online examinations, participants are required to work on a topic of their choice. Participants must submit a topic for the Term-end Paper, followed by a first draft of the Term-end Paper.

ADMISSION PROCESS

Interested applicants are required to submit soft copies of the following documents at the time of application:

- Curriculum Vitae (CV)
- Copies of relevant qualification certificates (Graduation Degree or final semester mark sheet)
- Statement of Purpose (SOP)

Please note: Applications will not be accepted if any of the above documents are missing.

STEP 1 Register Online



- Visit our website and complete the registration form.
- YOU MAY APPLY FOR ONE COURSE ONLY.
- Upload all required documents in one consolidated PDF file, named in the following format: *yournamebirthyear* (all lowercase, no spaces, no symbols). For example <u>varun1996</u>
- Upload a recent passport-size photograph in JPEG/PNG format named in the following format: *yournamebirthyearpp* (all lowercase, no spaces, no symbols). For example <u>varun1996pp</u>
- Upon submission, a confirmation pop-up will appear, indicating that your application has been successfully registered.

STEP 2 Application Review

- The Admissions Committee will review all **complete applications**.
- The Committee may hold telephonic interviews in certain cases.
- Within two weeks of submission, applicants will receive an email with fee payment instructions, subject to acceptance of their application.
- Due to large number of applications, we are only able to contact those who are selected.

STEP 3 Fee Payment

- Pay the course fee as per the instructions received in mail.
- Upload the proof of payment via the Google Form link provided in the acceptance email.

STEP 4 Admission Confirmation

- Payment verification may take up to 5-7 working days after the candidate submits payment details.
- Once verified, the applicant will receive a formal confirmation email along with the course commencement date.
- On the day of course commencement, the Candidate shall receive a welcome mail along with their Log-in Credentials for our Student Portal.



FEE DETAILS

- Fees for PGDELP is Rs. 16,000 (Rupees Sixteen Thousand Only).
- Fees will only be accepted once admission has been confirmed.
- Please DO NOT send in fees along with the application form (through any mode).
- After the offer of admission is made to the participant (i.e., the participant is selected), the applicant may proceed to pay the fees via 'Online Transfer' to confirm admission.
- If an applicant is unable to pay via 'Online Transfer', the applicant may issue a
 Demand Draft drawn in favor of 'World Wide Fund for Nature India' payable at
 New Delhi (Candidates name and phone number to be appended behind Demand
 Draft)
- The fees once paid will not be refunded.

Kindly ensure that the full fee amount is credited to WWF-INDIA after clearing all additional dues that such a transfer may attract.
